

NUMBER PLATE AUCTION

BIDDING REGISTRATION & PROCEDURE



Bidders and Proof of Identity

Bidders must supply proof of identity to Shannons by providing either;

- A. A valid NSW driver/rider licence or NSW photo card **OR**
- B. Two Proof of Identity documents acceptable to Roads and Maritime Services (for a list of acceptable documents see <http://www.rms.nsw.gov.au/roads/licence/identity/>).

It is a requirement of Roads and Maritime Services ("RMS") that bidders register in their own name not a company name.

Acting on behalf of a Company

A person acting on behalf of a registered Company will be required to provide personal proof of identity (as above) and authorisation from the company to act on its behalf. See requirements at:

Receiving Plates on behalf of a Company

A person who has the receipt from Shannons and provides authorisation from a company (as above), can have the Numeral Only Plates registered in the name of the company at no Transfer fee with completion of Form 1098 within two weeks of the Auction. See at this link:

Fees Payable to Auction House

As set out in the standard auction terms the successful bidder must pay a 10% deposit immediately after the fall of the hammer. The balance of the price is payable to Shannons within 2 working days. Once payment has been cleared Shannons will provide a receipt which RMS/Service NSW will accept as evidence of payment.

Receiving the Numeral Only Plates

The successful bidder will need to attend the Chatswood Service NSW service centre at 313 Victoria Avenue Chatswood within two weeks of the date of the Auction and lodge completed Roads and Maritime Number Plate **Form 1038** and the auction payment receipt from Shannons.
